- Oversee community engagement projects such as health education and free medical screening events.
- Liaise with partner clinics, NGOs, and community leaders to ensure smooth implementation.

4. Monitoring & Evaluation

- Develop and track key ESG performance indicators (KPI's).
- Prepare progress updates, presentations, and impact summaries for stakeholders.
- Identify risks, gaps, and improvement opportunities in project delivery.
